All outstanding balances are to be paid within twenty-four hours after notification of a successful bid. Unsuccessful bidders will have their deposit(s) sent to them within five business days following conclusion of the auction sale.
- Once the bid is placed, it cannot be withdrawn after the auction sale has commenced.
- All absentee bidders are required to provide **the greater deposit of twenty-five percent (25%) of the total maximum bid amount or \$1,000.00** with the completed and signed absentee bid form(s). All deposits and payments shall consist of wire transfer, cash, cashier's check, or other certified funds made payable to Daley-Hodkin LLC.
